FIDUCIARY ABUSE

A conservator is someone authorized by the court to manage your affairs. A conservator may be appointed if you become unable to make sound decisions, feed or dress yourself, handle your own finances or resist undue influences. If it is possible, it is best to use a family member or trusted friend as your conservator. Conservators have come under scrutiny in the last few years when local newspapers profiled abuses by conservators that involved seniors being duped into signing away their rights without their knowledge.
